**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan<sup>®</sup>/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan<sup>®</sup>/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan<sup>®</sup>/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

## 2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at [www.usdf.org](http://www.usdf.org). Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

### Membership/Registration Requirements for Qualifying and Championships

*All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.*

Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

\* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

## General Information and Rules of the Show

**RULES:** “EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.” For specific rules, please refer to the current version of the USEF Rule Book.

**USEF MEMBERSHIP:** This is a U.S. Equestrian Federation licensed Dressage Competition, and the rider, owner, and trainer must all be U.S. Equestrian Federation active members or pay a non-member fee directly to U.S. Equestrian. **The show can no longer accept Show Pass fees. You must purchase that online at the USEF website prior to the show.** <https://www.usef.org/show-pass>. Please include copies of the US Equestrian cards with your entry, they can be printed out from the US Equestrian website.

**USDF MEMBERSHIP:** Owners and riders MUST provide a copy of their current USDF membership cards (Participating or Group) with their entry forms. If the horse owner or rider is not a USDF member, they must pay the USDF non-member fee of \$55 per person.

**HORSE IDENTIFICATION:** The **HORSE** must have either a Horse Identification Number (HID) issued by the USDF, or a Lifetime Horse Registration (LHR) issued by USDF. Please include a copy of the HID or LHR certificate. See USDF membership page for further membership details. **The horse must also have either a USEF Life, Annual, or Horse Identification Number**, please include a copy of this card with your entry.

**AMATEUR CERTIFICATION:** Riders in Adult Amateur division must be at least 21 years old and hold a current USEF Amateur card. A copy of this card must be included with the entry form.

**OPPORTUNITY CLASSES:** Offered at the Intro and Training Level. Opportunity classes are offered for entry level participants to encourage participation in Federation licensed competition. Horses, riders, trainers,

and coaches participating only in Opportunity classes are exempt from Federation and USDF membership and horse identification requirements, and USDF non-member/USEF show pass fees; but if the participant is a USEF and/or USDF member, they are required to list their membership number.

Horses entered only in these classes must comply with the Drugs and Medications rules and are subject to USEF drug testing. But Horses entered only Opportunity these classes are exempt from the Federation Drug & Medication fee (USEF fee: \$25).

Horses and/or riders entered in the Opportunity classes may cross enter into the recognized classes, but if they enter the recognized classes, all applicable fees and membership requirements apply. See USEF GR 821 for the complete Rule applicable to Opportunity Classes.

**GREAT AMERICAN/USDF QUALIFYING CLASSES:** There is a \$20 Great American Insurance Group/USDF Regional Championship qualifier fee in addition to the entry fee for the test that the competitor wishes to have recorded as qualifying. Please see the 2026 Great American Insurance Group/USDF Regional Championship page for qualifying details.

**ENTRIES: Due to excessive fees from some online entry platforms and credit cards, this show is going old school. All entries must be paid by either check or Zelle.**

**No credit cards will be accepted.**

If e-mailing your entry, please include both sides of the signed entry form, the signed USEF liability waiver, and copies of all cards. Entry forms must be readable on a computer.

Entries are accepted on a first come, first served basis by on-line entries or mail. Please use the attached entry form for mail-in entries and on-line entries. Photocopied entry forms (both sides) are acceptable. **Each horse and rider combination requires a separate entry form. There is only one USEF (\$25) fee per horse, please pay that on the entry for the primary rider.**

The complete name and address of **the registered owner** must appear in the “owner” space. If a farm name is used as the “owner,” the farm must have a USEF farm membership and be listed as the owner on the horse’s USDF HID or LHR certificate and USEF HID or Registration. A copy of the Farm/Ranch membership card **MUST** accompany the entry and the Farm USEF number used as the owner USEF number.

**Required Signatures:** Owner (or agent), trainer, and the rider must sign the entry form (adult signatures only) in the spaces provided and provide addresses, and telephone numbers. **Don’t forget to fill in the Emergency Contact information.** If the owner is the trainer, owner must sign in BOTH the owner and trainer spaces. A trainer is “any adult who has the responsibility for the care, training, custody, or performance of a horse” not necessarily who you take lessons from.

Junior exhibitor’s name, address, and birth date along with the parent’s or guardian’s signature **MUST** appear in the “Minor Permission” area on the entry form for all juniors exhibiting in the show.

Total entry fees and all other applicable fees must accompany each entry by check/ money order or zelle payment. Post-dated checks will not be accepted. Entries received without payment will not be processed until payment is received and will be subject to post entry fees if payment is postmarked after the close of entries.

\*\*\* GR 845.1 requires that all horses brought onto the grounds must also have documentation of the Equine Influenza Virus and Equine Herpes Virus (Rhino) vaccinations within six months prior to the show. Please bring proof of this to the show to be shown to officials upon request.

All horses brought onto the grounds must have a completed entry form and be issued a number, even if they are not competing. See Non-Competing Horses below for full specifications.

**CANCELLATION OR SUBSTITUTION OF ENTRIES:** To encourage early entries the management agrees to refund the entry, except the office fee, on any entry withdrawn in writing (e-mail) prior to the closing date (August 1). On the closing date and until Monday August 3 (5 days before the show) a refund of entry, except the office fee, will be made for a horse not fit to show provided that written notice and a veterinary certificate are given to the show secretary by August 3. Cancellation of entries after this date, for any reason, forfeits all fees except those which are paid to the USEF and USDF only if the horse competes. After the show commenced no exhibitor may withdraw a horse from the show or remove them from the show grounds without the permission of the Show Management.

If the rider is unable to compete due to contracting or being exposed to COVID 19 prior to the closing date, management agrees to refund all fees, except the office fee, upon written notice (e-mail is fine) to the show secretary by midnight August 1, 2026. After the closing date, but before the show starts, riders unable to compete due to COVID 19 will receive a refund of the USEF fee, any USDF qualifying fees. After the show commenced, there is no refund.

**POST ENTRIES:** **Entries for the Road Runner North show must be received ON OR BEFORE the Closing Date of AUGUST 1, 2025 to avoid the Post Entry Fee of \$35 per horse.** Post entries will only be accepted if there is time available to schedule the ride. **Once the maximum number of 60 rides for this show is reached, any subsequently received entries will be notified and placed on a waiting list.**

**PERMANENT JACKET WAIVER:** Since this show is held in a climate with high average heat in the summer, **jackets will be waived for the duration of the competition.** DR 120(2). Don't forget, your shirt must have sleeves. DR 120(2.1)

**NON-COMPETING HORSES** Non-competing horses are allowed on the show grounds under the following conditions: **1)** a signed entry form acting as a liability release; **2)** payment of the \$40 Office Fee; and **4)** a non-competing horse fee of \$25. Proof of Equine Influenza Virus and Equine Herpes Virus (Rhino) vaccinations within six months prior to the show must be available to be shown to officials at the show if requested.

**DRUGS & MEDICATIONS FEE:** Current USEF Rules regarding drugs and medications will be enforced. Except those ONLY showing in the Opportunity classes, all horses entered in this competition must pay a Federation fee of \$25.00. This is composed of \$15 for drugs & medication research + \$10 Federation fee.

**REFUSAL OF ENTRIES:** Show Management reserves the right to refuse, accept conditionally, or to cancel any entries of any exhibitor in accordance with USEF rules.

**RETURNED CHECKS:** All returned checks will be assessed a \$65.00 charge. The exhibitor will have 10 days from notice of the returned check to pay the debt before Show Management reports the debt to the USEF and local authorities.

**STABLING:** There is NO Stabling on the show grounds. There will be limited stabling available off the show grounds. Contact the Stabling Coordinator Rebecca O'Connor at the 770-855-5445, e-mail: [roc251@comcast.net](mailto:roc251@comcast.net)

**THERE IS NO HAUL-IN FEE for showing off your trailer.**

**SHARPS CONTAINERS:** Trainers, owners, exhibitors, or agents, you are on notice that improper disposal of needles or other sharp disposable instruments will result in fines of \$100 per occurrence. There will be a sharps containers available at the secretary's office.

**PRIZES & AWARDS:** Ribbons -- First through fourth place. A prize for first place, plus a grand prize drawing for a special prize. Prize drawing tickets are prepared as follows: 1 ticket for each entry; 3 tickets for each perfect entry, and 1 ticket for each first place. Other prizes may be added to the drawing.

**DRESSAGE CLASSES & RIDE TIMES:** The dressage classes will not necessarily run in the order listed. To accommodate the late closing date, competitors will be notified of their ride times via e-mail no later than Wednesday August 5. The show is anticipated to start at 8:00 AM. A time schedule will also be available in the Secretary's office before noon on Friday, August 7.

**ARENAS:** Covered Arena (Show): 100' x 200', footing is sand mix over natural base. Warm up in arena . 116' x 200'; footing is sand mix over natural base. Lounging is not allowed in either the show or warm-up arena. The lounging location is a separate designated arena with a sand mix over a natural base footing.

**SCHOOLING:** Schooling is allowed in the show arena and warm up area after 1:PM on Friday. Schooling in the show arena on Saturday may be permitted if time allows. Ask at the show office. The number of riders schooling at any one time will be limited for safety reasons.

**JUDGES:** If for any reason the judge fails to attend this show or to perform his/her duties, Show Management reserves the right to substitute a judge for the one who is officially designated in the Prize List.

**LOCATION OF CLASSES:** Show Management reserves the right to change the location of the classes if necessary and to modify the schedule if entries warrant.

**BIKES AND MOTORIZED VEHICLES:** Minors must wear safety helmets when riding bicycles per AZ State Law. Bikes and/or small motorized vehicles are NOT allowed in the paddock areas in front of the show arenas. If bikes or motorized vehicles are used improperly at the American Ranch, they will be confiscated until the end of the show for the protection of exhibitors and their horses.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of a licensed competition. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. **The parent(s), legal guardian(s) or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.** Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**DOGS:** NO dogs permitted on the show grounds.

**PARKING:** Parking for trailers and other vehicles is in designated areas only. There will be a parking coordinator to help with parking. Please respect the no parking signs. Show management reserves the right to move a vehicle that is in violation of the no parking zones.

**PROTECTIVE HEADGEAR:** All riders in the dressage division must wear protective headgear complying with USEF dressage rules at all times when mounted. DR120(1.1). From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. The harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place.

**FARRIER:** A farrier will be on call for the show and the farrier's number will be posted in the Secretary's office, in the stabling area, and placed in the competitor packets.

**VETERINARIAN:** There will be a veterinarian on call. The number for the veterinarian on call will be posted in the Secretary's office and placed in the competitor packets. The on-call veterinarian is Prescott Animal Hospital Equine Center 928-776-7669

**DIRECTIONS TO AMERICAN RANCH:**

1. Follow **I-17 N** out of Phoenix to **Exit 262** (AZ-69 N/Prescott).
2. **Stay on AZ-69 N** through Cordes Junction for about 21 miles.
3. **Turn right onto Fain Road.** Fain Road naturally transitions directly into **AZ-89A N**.
4. **Stay on AZ-89N** past the Prescott Valley exits and
5. **go straight as 89A ends** and turns into Pioneer Parkway.
6. **Follow Pioneer Parkway to N. Williamson Valley Road.**
7. Turn **right on N. Williamson Valley Road** and head north for 5 miles.
8. Turn left onto American ranch Road, then make an immediate left and continue on N. Americal Ranch Road.

9. **Turn left at the first street**, N. Callahan Road and follow for 2 blocks. The Equestrian Center will be on the right hand side.

**US EQUESTRIAN FEDERATION MEMBERSHIP STATEMENT: Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.**

**INDEMNITY AND NON-RESPONSIBILITY CLAUSE:** All entries are accepted with the understanding that Horse Show Management LLC, Northern Arizona Dressage Club, Inc., American Ranch Community Assn., HOAMCO, all employees, agents, and volunteers will not be held responsible for any loss, damage, or injury to any horse or property at the show. Further that anyone signing the entry form assumes all risk for any injury to themselves, other persons, horses, or damage to any property and agrees to indemnify Horse Show Management LLC, Northern Arizona Dressage Club, Inc., American Ranch Community Assn., HOAMCO, all personnel, employees, and volunteers against all loss, damages, and liability, including, but not limited to, all legal costs and attorney fees.

### **EQUINE VACCINATION RULE**

GR 844.1 requires that horses entering the grounds at a Federation licensed competition **MUST** be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.

Documentation should consist of either:

**A)** Documentation (invoice) from the veterinarian showing the horse received the vaccinations including the name of the vaccines and the date of vaccine administration. See USEF GR 845.2; or

**B)** If a person other than a veterinarian administers the vaccines, documentation for this rule consists of: a copy of the receipt of the vaccine purchase that is signed by the owner, or agent with care, custody, and control of the horse; the name, serial number, and expiration date of the vaccine; and the date of vaccine administration. See USEF GR 845.3.

**SAFE SPORT STATEMENT:** All USEF Life and Senior Active members, as well as participants, who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF INHERENT RISKS: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equine activities, including but not limited to horseback riding and equestrian sport, are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").
